

Terms and Conditions of “Credit Card Installment Loan Lucky Draw” (“Program”):

- THE PROGRAM** – This Program is only available for selected cardmember who is/are successful applicant(s) of CCB (Asia) Credit Card “Chill” Spending Installment Program (“**Spending Installment Program**”) approved by China Construction Bank (Asia) Corporation Limited (“**Bank**”, “**we**”, “**us**” or “**our**”) with applications made under this program from October 1 to November 30, 2024 (both dates inclusive) or within such extended or shortened period as we deem appropriate (“**Promotion Period**”).
- ELIGIBILITY** – Cardmember who has/have applied for Spending Installment Program with loan amount HKD30,000 or above and tenor 12 months or above (“**Eligible Spending Installment Program**”) can enjoy Lucky Draw Chances.
- LUCKY DRAW DETAILS** – Cardmember who has/have applied for Eligible Spending Installment Program with loan amount HKD30,000 can enjoy 3 Lucky Draw Chances. For every HKD10,000 extra loan amount beyond HKD30,000 can enjoy extra 1 lucky draw chance. If extra loan amount beyond HKD30,000 does not meet HKD10,000, no extra lucky draw chance would be granted. Please refer to below examples:

| Example | Spending Installment Program Loan Amount | Tenor | Lucky Draw Chance | Remark |
|---------|--|-------|-------------------|--|
| 1 | HKD20,000 | 12 | 0 | Not eligible loan amount |
| 2 | HKD40,000 | 6 | 0 | Not eligible tenor |
| 3 | HKD30,000 | 12 | 3 | - |
| 4 | HKD39,000 | 24 | 3 | The extra loan amount beyond HKD30,000 is HKD9,000. Not meeting HKD10,000. |
| 5 | HKD90,000 | 48 | 9 | - |

Remark: If cardmember applied for 1 or more Eligible Spending Installment Program, when Lucky Draw Chances are calculated, Lucky Draw Chances would be calculated based on each individual eligible applicable. Loan amount of different applications would not be added up for Lucky Draw Chances calculation.

- REWARDS** – A total of 120 winners will be randomly drawn by a computer system of the Bank from all the eligible cardmembers meeting the requirements (“**Lucky Draw Winner**”). According to the above Terms and Conditions, Lucky Draw Winner shall be entitled to HKD3,888 Spending Credit (“**Cash Rebate**”).
- NOTIFICATIONS** – The Bank would send notification letter/ SMS to notify the Winner by 31 December 2024. Cash Rebate will be credited to eligible Principal Card account by 31 December 2024.
- RESTRICTIONS** – Each applicant can receive the Cash Rebate once during the promotion period. The Spending Installment Plan has to remain valid and in good standing at the time of fulfillment in order to be eligible for the Cash Rebate. The Bank would check the Installment Program status within 1 year after the fulfillment of Cash Rebate. If Eligible Customer chooses to make early settlement or cancel the Installment Program, the Bank reserves the right to charge such Eligible Customer an amount equivalent to the amount of the Cash Rebate granted. Cash Rebate can only be applied against outstanding in Card account statement. Cash Rebate cannot be converted into cash, and / or withdrawn as cash and is not transferable. If the Cash Rebate amount would be drawn by any means as cash or transfer to other accounts, relevant fees and charges will be incurred. Please refer to relevant Terms and Conditions for details.
- Lucky Draw is not applicable to staff of the Bank.
- FINAL DECISION** – We may terminate or withdraw the Program at any time without notice and have the final decision in all matters and disputes in relation to the Program, and may vary any relevant details and these Terms and Conditions. We shall not be responsible or liable for any claims or liability in relation to use of the Program howsoever suffered or incurred by any Applicant or other person.
- ENGLISH VERSION PREVAILS** – In case of any inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
