- 4. The credit card number of your World Mastercard will be the same as your JD Card. Upon activating the World Mastercard, your existing account information of the JD Card, including the account balance, bonus point balance and Octopus Automatic Add Value Service (AAVS), will be carried forward to the Mastercard automatically. Credit limit, fees and charges (if applicable), interest rates and terms and conditions will remain unchanged.
